2019 Preferred Contractor Destinations Trip

Trip Rules and Guidelines

- The Preferred Contractor Destinations trip is open to the qualifying Preferred Contractor and spouse or contractor and legal business partner. Only the qualifying contractor and one other person (either spouse or legal business partner) may attend the business session. Proof of 33% legal partnership is required with application if the qualified contractor plans to include a business partner.
- A confirmation email and letter with instructions for online trip registration will be sent to all qualified contractors. Online registration for the qualified contractor and guest must be submitted no later than the date specified in the confirmation letter or the trip will be forfeited.
- The Preferred Contractor Destinations trip is only valid for the dates scheduled.
- All Destinations trips have no cash value. If the qualified contractor chooses not to participate in the Destinations trip, it may be exchanged for two (2) registration fees and two (2) nights of lodging for the Conklin 2020 National Convention.
- Only one (1) Preferred Contractor Destinations trip may be earned during the qualifying period.
- Conklin reserves the right to withhold or withdraw the Preferred Contractor title and trip for any individual whose account is overdue at any time during the qualifying period.
- Meals and activities not specified in the program will be at the traveler's expense. This includes pre- or post-trip extensions.
- Conklin will issue a 1099 tax form to the qualifying Conklin identification number for the Destinations trip.
- Contractors earning the Gold Level Destinations trip will receive a travel allowance in the form of a check. The amount of the transportation allowance will be calculated in advance for each trip and will be the same for each traveler regardless of point of origin. (Travel allowance will be calculated 60 days prior to travel based on the average non-refundable airfare from ten (10) common airports to the destination. If a single traveler attends, one (1) transportation allowance will be provided; if two (2) qualified travelers attend, two (2) transportation allowances will be provided. Travelers are responsible for purchasing airline tickets.)
- Cancellation 30 days or less prior to travel will result in a cancellation fee. Gold Level travel allowances will not be issued to those who cancel.
- Conklin Company reserves the right to make changes to this program at any time without notice.

Preferred Contractor Emeritus Trip Guidelines

A Preferred Contractor Emeritus may participate in the Preferred Contractor Destinations trip, program meetings, and group activities, provided that he or she has achieved Preferred Contractor in at least ten (10) previous years and has a personal purchase volume of \$25,000 within the qualifying period. Conklin will provide half of the program expenses* for any Preferred Contractor Emeritus who chooses to participate in the Preferred Contractor Destinations trip. The other half of program expenses will be paid by the Preferred Contractor Emeritus at time of registration. After participation in five (5) Preferred Contractor Destinations trips, a Preferred Contractor Emeritus may continue to attend the program at is or her own expense.

* Program expenses include lodging, program meals, and transfer to and from airport on scheduled arrival and departure dates.

Honorary Preferred Contractor Trip Guidelines

An Honorary Preferred Contractor may participate in the Preferred Contractor Destinations trip at their own expense. An Honorary Preferred Contractor who develops two new personally sponsored Preferred Contractors within one (1) qualifying period will receive the Gold Level Destinations trip.
